- 1) <u>Ridership Update</u>- Last month saw some decreases in total ridership, but average daily ridership was about the same as previous months.
  - a. Daily ridership across fixed route was around 2,800 rides per day.
  - b. The Northstar Link saw one of the largest increases last month with 720 passengers.
  - c. Connex had 1032 rides provided.
  - d. Dial a Ride recorded 10,532 rides.
    - i. Average daily ridership is beginning to increase, if possible, schedule trips well in advance.
    - ii. If you call to schedule a ride, please be patient as we are experiencing high call volumes and are doing our best to provide the upmost service standard we can!

### 2) Weather Changes

- a. Watch for melting and refreezing.
- b. This means snowbanks areas are quickly shifted from files of snow to hard, packed ice and are less forgiving if walked on, driven into etc.
- c. Please be weary when near buses, facilities and while at bus stops.
