11.) CEO Update. Ryan Daniel presented the Commissioners with a look at the new bus route signs that will be rolled out with the progression of the Metro Bus Forward long-range transit plan. Mr. Daniel added that he, along with a few other Metro Bus representatives, recently attends a Waite Park City Council Meeting to address concerns and answer any questions regarding the addition of the Waite Park Transit Station. Metro Bus was the recent recipient of a federal grant that will go towards the future purchase of CNG replacement buses. Metro Bus completed its fiscal year 2025 financial audit. A presentation from BerganKDV will be coming in early 2026.
